2017 Indoor Coed Volleyball Rules

Wednesdays, 6:30 pm & 7:45 pm, Cape May Elementary School Gym, 921 Lafayette St., Cape May

League Play will begin Wednesday, March 29th with a deadline to submit a team by Monday, March 27th.

League fee is \$200 per team. Referee fees are included.

Minimum age is 17. Participants younger than 18 must have parental consent to play.

All teams must complete this registration form and each participant must complete the attached waiver.

1. USVBA rules will apply unless specified otherwise.
2. Low Ceiling: A team may play the ball off the ceiling and the large metal blower boxes as long as the ball is controlled on their side of the net.
3. If the ball strikes the hanging ropes or backboards it will be considered a dead ball. If the ball gets hung on the top of the blowers it must be played over.
4. Teams must have a minimum of six and a maximum of 10.
5. Rosters must be turned in by Monday, March 21st. Changes will be permitted until Wednesday, March 23rd.
6. A team will not be permitted to continue to play until the league fee of \$200 has been submitted to the City of Cape May. Address is as follows:

7. Substitution: Rotation of players and/or unlimited substitution by player and position may be used.
8. Matches will consist of four games to 21 points. Fourth game may go to 15 at referee's discretion based on time remaining in match.
9. Teams must win by at least two points. Rally scoring will be used in every game.
10. Playoffs: All teams will qualify for the playoffs. Players must participate in at least half of the regular season matches to qualify for the playoffs.
11. Player ejection: First offense is a one match suspension. Second offense is a three match suspension; Third offense the player is suspended for the remainder of the season.
12. Number of players: Maximum of three men on court for a five or six member team. Maximum of two men on the court for a four member team.
13. No matches will be cancelled unless initiated by the Department of Recreation.
14. Grace Period: Five minutes prior to each game forfeit; 10 minutes for a match forfeit.

Why Waivers?

The City of Cape May requires all players to sign a waiver prior to playing in our leagues. The reasons for this are as follows:

Liability: The waiver helps players understand that there are risks associated with playing adult sports and that by participating in The City of Cape May events, you are assuming these risks.

Sportsmanship: The league asks that everyone who plays in our leagues display good sportsmanship at all times, under all circumstances. By signing the waiver you agree to participate in our leagues with good sportsmanship.

Player Information: The waiver allows us to collect important information about our players if we should need to contact you for cancellations, time changes, etc. We DO NOT sell or give player information to other organizations.

WAIVER FOR PARTICIPANT: In consideration of accepting my/my child’s entry, I hereby, for myself, my child, my heirs, executors and administrators, waiver and release any and all rights and claims for damages I or my child may have against the City of Cape May or school district and it’s representatives, successors and assigns for any and all injuries suffered by myself or child at any activity sponsored by these groups.

SPORTSMANSHIP AND FAIR PLAY AGREEMENT:

1. I have read, understood and will abide by the rules of my sport as outlined the City of Cape May; **2.** I understand that if it is reported by the official, Recreation Staff or an opponent, that I have behaved in an unsporting manner or have not played by the rules, that I could be suspended or ejected from the league, with no refund. **3.** I understand that my team captain is the only person who can approach the official regarding concerns surrounding the game. It is my responsibility to let my captain know my concerns so he/she can deal with them.
